Dear Mr. Guarino:

The purpose of this letter is to provide you an update on the Tri-Borough and County Thorium Coalition's (TBCTC) expenditure of funds under DOE's technical assistance program. The grant was awarded to your group for a total of \$50,000; as of March 31, 1995, \$7,828.88 has been spent. This leaves approximately \$42,171 available for the TBCTC to spend in reviewing DOE activities associated with the Maywood site.

In addition, DOE has made changes in the way grants under their technical assistance program are to be administered. As such, the technical services agreement has been modified to reflect these changes. I have enclosed a revised Technical Services Agreement for the TBCTC with all changes noted in **bold type**. In addition, please note that work under this technical assistance program will not be authorized for conducting independent studies; work shall be performed to review technical information issued by DOE related to the Maywood site. All work to be performed under this grant must be pre-approved as shown on the form attached to the revised technical services agreement.

We will be working directly with Teledyne to make the necessary modifications to their subcontract to incorporate these changes. These new procedures should be implemented by the TBCTC no later than May 1, 1995.

## TECHNICAL SERVICE AGREEMENT FOR USE BY THE TRI-BOROUGH AND COUNTY THORIUM COMMITTEE

Teledyne Isotopes (Teledyne) will work under the direction of the Tri-Borough and County Thorium Committee (TBCTC), with all work pre-approved by Bechtel National, Inc. and/or the Department of Energy.

All reports prepared by Teledyne will be delivered solely to the TBCTC.

Guidance for communication between Teledyne and the Department of Energy (DOE) and DOE contractors will be provided by the TBCTC.

Teledyne will enter into a subcontract with Bechtel National, Inc. (BNI), DOE's project management contractor for the Maywood site. The sole purpose of this contract is to provide funding. Teledyne will not take technical direction from DOE or BNI.

The subcontract will be for a maximum of \$50,000 for the duration of August 1, 1992 (actual date dependent on establishment of above subcontract) through September 30, 1995. This duration will allow the TBCTC to review all DOE activities and plans until the completion of the Record of Decision for the Maywood site. NOTE: Subcontract duration will be extended for scheduled period of performance if Record of Decision has not been issued by DOE. Additional funds will not be provided.

Once the subcontract is in place, billing statements will be presented by Teledyne to the TBCTC which will verify the statements and send them to BNI for payment. It is recommended an individual be identified who is authorized to verify these statements without convening all members of the TBCTC. All work under the subcontract will be preapproved by Bechtel National, Inc. and/or the Department of Energy.

BNI will expedite processing of pre-work approval forms and payment of Teledyne and provide trending information to the TBCTC.

Funds provided to Teledyne cannot be used to underwrite or support legal actions for intervention in DOE's environmental review process of the Maywood Site.
